

Tournament Details

Teams: For both sessions we're preparing for a field of twenty-four teams at 15U, twenty-four teams at 13U and eight teams at 11U. International Teams are assigned to separate pools to maximize the number of teams that get the opportunity to play an international team in pool play. Pools will be created and opportunities to play international teams determined by the date your registration is completed. **15U teams from McHenry County are required to provide at least minimum homestay in order to play in the tournament. Contact us for details.**

Player Age Rules: Contact Dan Malone (contact info below) with questions or requests for consideration

- 15U All players who are 15 years old or younger on April 1, 2026 are eligible. Players who are 16 on April 1 are eligible if the player is a High School Freshman in the Spring of 2025. A player cannot be 17 on the first day tournament games are played.
- 13U All players must be 13 years or younger on April 1, 2026
- 11U All players must be 11 years or younger on April 1, 2026

Games: NO TIME LIMITS - All games played to completion. Two umpires every game. NO GATE FEES.

Format:

- **15U-** Minimum of five games for each session.
- 13U & 11U- Minimum of four games for each session

Fields: Our goal is to provide the best available fields with the shortest distance between locations. Fields may include McHenry County College and Judson University and may include Turf fields. PLEASE NOTE SPECIAL TURF FIELD & FACILITY RULES: NO METAL CLEATS. NO GUM OR SEEDS ANYWHERE IN THE TURF COMPLEX.

NOTE: This includes the fan area. Teams violating turf field rules will be subject to penalties.

15U- 60' mounds and 90' bases **13U** - 54' mounds and 80' bases **11U** - 50' mounds and 70' bases

Awards: ALL AGES - Individual Awards for 1st and 2nd Place in Gold & Silver brackets (if applicable).

Admissions: There will be NO per person admission charge. Coolers are allowed in all complexes.

Concessions: Will be available at most locations.

Refund Policy: Once you're paid in full, 100% refunded if you cancel by May 1, 50% if by June 1.

Rainout Policy: Should weather cause an event to be completely canceled having played no games, all teams will receive a full entrance fee reimbursement less \$100 to cover costs. Should just one game be played before an event is canceled, due to weather, a **refund** will be issued for 40% of the value the participating team paid to play in the event. There will be no refunds after the start of each teams' **second** game. If a team elects to leave before playing a rescheduled game, then they forfeit any potential refund.

Housing: All teams traveling more than 100 miles to play in our tournament are required to book directly (no 3^{rd} parties) at tournament partner hotels or pay a waiver fee of \$500 per session. Information on Partner Hotels can be found on our website.
